HAGERTY PRIVACY PRACTICES & POLICIES:

Confidentiality and security of your information:

- › We do not share your information except as described in this policy.
- › We have set up physical, electronic, and procedural safeguards. These safeguards comply with state and federal laws and rules in order to protect your information.
- › We limit access to your information to employees who need to know. Employees may need to know in order to service your needs.
- › We educate our employees on protecting your privacy. We also take proper measures to enforce our privacy responsibilities.
- › We expect third parties that provide services on our behalf to keep your information private. We also expect them to use your information only to provide the service we have asked them to provide.
