At Hagerty, we respect your privacy and protect your nonpublic personal information ("your information"). Hagerty does not sell your information. Hagerty does not share your information with unaffiliated third parties that would use that information to contact you about their own products and services beyond what is listed below in this notice and allowed by law. This notice describes how Hagerty collects, uses, shares and protects your information.

### HAGERTY PRIVACY PRACTICES & POLICIES:

#### Confidentiality and security of your information:

- › We do not share your information except as permitted or required by law and described in this policy.
- › We maintain physical, electronic, and procedural safeguards that comply with state and federal regulations to protect your information.
- › We limit access to your information to those employees who, in order to provide you products and services, need to know.
- › We educate our employees about protecting your privacy, and we take appropriate measures to enforce our privacy practices and responsibilities.

#### Parties with whom we may share your information as permitted or required by law:

We may share your information, without authorization from you, with our affiliates and third parties. We may, for example, share your information with:

- › Our underwriting company or your agent or broker;
- › Insurance regulatory agencies in connection with the regulation of our business;
- › Persons who need the information to investigate, defend or settle a claim;
- › Persons requesting information pursuant to a subpoena, court order or as otherwise required by law;

- › Third parties who perform professional, business or insurance services on our behalf.

If the law in your state permits, we may also, without authorization from you, share your information with:

- › Third parties with whom we have joint marketing agreements for the sale of our products; and
- › Financial institutions for the purpose of marketing financial products or services offered pursuant to joint agreements.

#### Information we may collect about you:

- › Information you provide to us. For example, information you provide with your application or quote.
- › Information from consumer reports,\*\* such as motor vehicle records.
- › Information concerning your policy coverage and premium.
- › Information about your additional transactions with us, our affiliates or others.
- › Information otherwise submitted by you, such as information filled out in surveys or questionnaires.

#### Information we may share with affiliates and third parties as permitted by law:

- › Information you provide to us with your application, which may include your name, mailing address, and e-mail address.
- › Information about your transactions with us, our affiliates or others, such as information about your policy coverage or information about the products and services you request or purchase.
- › Other information submitted by you, such as information filled out in surveys or questionnaires.
- › Information collected from consumer reports will not be shared with affiliates or third parties except for such purposes as claims handling, servicing, underwriting, or as otherwise required by law.
